Credit Card – Property Tax Accounts may be paid online by major credit card using a third-party service provider. Halifax Regional Municipality (the municipality) uses a third-party provider, Plastiq, that charges a fee for this service. Please visit plastiq.com for more information.

Pre-authorized Payment Options:

- **Due date option** – On the due date, the municipality will debit your bank account for the balance due on this bill.
- **Monthly or bi-weekly options** – The municipality will debit your bank account monthly or bi-weekly for a set amount and apply it to your tax account.

Billing Information

- Go to epost.ca today to sign up to receive your tax bill online.
- The **bill date** of this bill represents the date it was generated. Changes between bill date and actual mailing and/or due date will not be reflected on this bill.
- An **interim bill** is calculated at 50 per cent of your estimated taxes. (Current year assessment multiplied by the prior year tax rates).
- A **final bill** is a calculation of assessed value times total Council approved rates less interim bill.

Assessment Appeals-Interest

Taxpayers are required to pay a bill, even if an assessment appeal is in progress and to avoid interest charges.

Interest Charges

Interest will be charged on any outstanding principal balance at a rate of 15 per cent annually (simple daily interest)

Returned Payment Policy

A \$40.00 fee will be charged on any returned payments.

Residential Tax Exemption & Deferral Programs
